Information on the Delorme Endowment Scholarship 2019

What this scholarship is:

An annual scholarship generated by the income donated by the Delorme Foundation in order to subsidize tuition for **one** St. Francis of Assisi Catholic School (SFS) student.

Who will be eligible for the scholarship?

- Any Pre Kindergarten - 8th grade student who desires to attend St. Francis of Assisi Catholic School.
- Student must **not** qualify for “low income corporate tax credit assistance” as described below.
- The Diocese of Tucson requires you to complete the FAIR tuition assistance application. A link to the application can be found at www.FAIRapp.com. Applications are accepted February 2 - April 4 of each year.
- Students must show effort and a desire to learn.
- Both a pastor and principal’s recommendation.
- Student must regularly attend Saturday/Sunday mass at a Catholic Church.
- The award will be contingent upon the student completing enrollment requirements.

How will the scholarship be awarded?

- Student will complete application and turn in to the SFS office by **October 1, 2019**.
- Student and parent(s) may be asked to appear in person for an interview with the Delorme Endowment Scholarship Committee.
- The Delorme Endowment Scholarship Committee will meet and review applications received. The decision of the committee will be announced no later than **October 15, 2019**.
- The scholarship will be paid directly to SFS on behalf of the student at the beginning of each school year.

What is required to maintain the scholarship?

For each school year, the student must:

- Be enrolled at SFS.
- Maintain a C+ average or better.
- Uphold the SFS Student Learning Expectations.
- Continue to attend weekly mass.
